Stencil Number on Specification and Bales

At times the information from a stencil holder overseeing a clip is not being handled in the correct manner. The stencil number should be put onto the bale in the space provided on the label and most importantly be included on the Wool Specification with the stencil holder's name (e.g. Q 1984- Mary James).

Providing the stencil holder fills out the Wool Specification, it is their job to fill in those details. If it the farmer is filling out the specification the stencil holder must advise the

farmer of their details and request they be added to the specification.

NZWCA operate a Merit award system and well classed and prepared clips are nominated by Wool Brokers/Merchants. If the details of stencil holder are not on the specification these clips could miss out on a nomination.

Whilst we are referring to specifications could I point out there are a significant number of clip with poorly filled out or no specifications that arrive with the wool.

Incorrect or insufficient documentation causes difficulty and expense to the receiver of the clip with time spent on sorting out the problems.

One of the jobs of the person in charge of the clip is to oversee that the correct detail are put into press book and on the bale. If that is done correctly it's only a matter of transferring those details onto the specification.

Providing this documentation is done correctly it will help the flow

Health and Safety Document

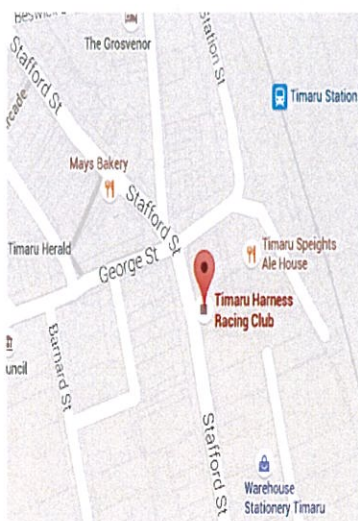

My Observations by Bruce Abbott

WHAT SHOULD WOOL CLASSERS CHARGE

Last season I was approached on a number occasions about what we should charge for our services. My view is the training we go through as Wool Classers qualifies us as trade people and you do not get a trade person for under \$50 per hour. So that is my bench mark. Therefore my min rate per day would be \$400, so taking that a shed is doing 800 sheep per day, that relates to 0.50c per sheep so that set the bench mark for charging on a per sheep rate, If the shed is doing 1000 per day the charge would be \$500. You adjust this formula if you consider the

hourly rate should be up or down of \$50. There are other charges to be considered such as ACC, I add a small percentage (6.5%) to my overall charges to cover this expense (Note; the Shearing Contractors do this). Other considerations include, do they supply accommodation, cover mileage and there may be others areas to be considered but that is on a case per case basis.

The main point I would like to emphasise is don't undervalue your services, charge a reasonable amount.

PROFESSIONALISM FOR WOOLCLASSERS

Last season going around a number of sheds and meeting you also gave me an opportunity to connect with our members. It was a pleasure going into some sheds that were well organized and the classer was very much in charge. These classers stood

out partly due to their presentation of working in a dust coat or overalls and their work place was well presented with wool stacked in bins and very good documentation procedures in place. Unfortunately in a couple of shed this was not to be the case, wool in bins all over the place, not a strict control on documentation and the classers just one of the shed hands working in ordinary clothes. The point I wish to make is if the classer is wearing a dust coat/overalls, to the shed hands and any person coming into the shed it identifies them as "this is the person in charge". It also saves a lot of washing as these garments protect your ordinary clothes (Please note, this year the NZWCA will have available dust coats with our logo for purchase at a very reasonable cost).

This article was in our last newsletter but I believed the points made about strength, length, fine micron and small lot is very relevant for this coming season.

As the season for harvesting and selling of fine wool is starting to draw to a close for what has been another difficult year for the super fine micron wool growers, there are several reoccurring market signals that can be drawn upon to highlight buying patterns.

As first stage service providers at the greasy wool harvest stage, wool classers and senior wool handlers have significant impact and influence on the final return for their Farmer clients.

While style, colour, VM content and fibre fineness are important features when preparing wool for market, the key drivers however continue to be uniformity of length and strength almost regardless of fibre fineness. The market has been more sensitive to variations of tensile strength and length, especially with the current buyers' market.

In the past, fibre diameter (or the lack of it) was the main driver in achieving premiums in the market place and consequently the national flock of merinos became finer as a result of Growers wishing to meet that demand. This strong market signal and demand at the time for the limited supply, rewarded Growers almost regardless of other processing fundamentals (mainly tensile strength).

With the desire to achieve ever increasing finer lines of wool for the market, Classers focused on classing out finer lines to the point where one to two bale lines became the norm and not the exception. This more than paid for extra testing and selling costs to meet the demand at the time.

The challenge became that as the clip became finer over time, it

became more difficult to achieve significant micron distinctions under 16 microns to justify the extra cost, the effort and the reward to do so. The reality, however was that there is more variation for fibre diameter along the strand of wool fibres than what can be achieved subjectively classed out lines for fibre diameter. By classing for fibre diameter, in fact only spitted out the average fibre diameter for the whole of the wool clip.

The market for the super fine was always, and still is today, a very select and niche market.

With limited super fine wool markets now being well supplied due to the finer micron national flock on both sides of the Tasman, this market now demands very high standards of entry (as with most fine wool markets today). The balance of the national clip being average to best topmaking styles, the price difference this season, based on micron only has been approximately only 200c/kg clean from 14 to 22 microns.

Bigger lines of wool uniformed for style and, more importantly, for good length and tensile strength (>38NKT) have achieved optimum returns for growers these last few seasons, reducing extra testing and selling costs. There have been up to 200 to 1000c/kg clean discounts for wool testing under 32NKT, especially for the super fine lots which unfortunately have been more common this year due to the difficult growing conditions.

It would be our view also that due to much lower premiums being paid for finer micron wools, Growers would save further costs and optimize their return by interlotting their below 3 bales of oddments with other similar Growers'



An Overview for training for the wool Industry at Lincoln/Telford Division



Over the past 12 months your Association and other industry groups in the wool industry have been working with Lincoln to establish training for our sector.

The Certificate in Wool Technology that was run by Tectra was in danger of disappearing with their closure. Lincoln took over the students and Tutor (Lauire Boniface) to enable the course to continue in the short term.

Since that time the group established by the wool industry (Wool Industry Education Group) to negotiate with Lincoln have been able to establish two courses for the future.

Certificate in Wool Technology (CWT): this course will provide individuals wishing to acquire a broad and theoretical knowledge of the wool industry with the opportunity to acquire and/or develop the requisite knowledge, skills and values.

Diploma in Wool Technology: this will provide individuals wishing to advance to a managerial or a specialist role in a specific aspect of the wool industry with the opportunity to acquire and/or develop the requisite knowledge, skill and values.

At the present time these courses are proceeding through the process for achieving approval by the different sections that oversee training in the universities. It is hoped that this will be completed by August 2016 and courses could begin delivery in September 2016.

This process has taken some time but the end result is that we will have training for our industry with a highly respected deliverer of courses, something that has not been present for over 20 years.

Meanwhile in addition to the former 14 Tectra trainees who are continuing their studies, eight people that had previously registered to start CWT course have been accepted into the current course.

Also the Lincoln- Telford Division has made arrangements for study towards one of the papers in the upcoming new Certificate in Wool Technology. They are endeavouring to have the Computing and Communications course (COMP 021) available by the end of May.
