7. Registrar's Report - circulated, taken as read

NZ Certificate of Wool Technology and Classing qualification review for the NZ Qualifications Authority NZQA The review of the Wool Technology qualification has been completed and submitted to NZQA for approval. The working group—facilitated by **Muka Tangata (Food and Fibre Workforce Council)**—was part of the scheduled five-year review process requiring industry input.

Key outcomes include:

- The qualification has been **elevated from Level 4 to Level 5**.
- Some subject matter previously removed when delivery moved from Lincoln and Massey Universities has been reinstated.
- The former Level 4 Wool Clip Grading qualification has been redeveloped as "Managing Wool Preparation in a Wool Harvesting Operation," aimed at leadership-level woolhandlers.
- The new qualification is available both as a Skill Standard and Micro credential, allowing flexible, standalone
 delivery or integration into the Certificate in Wool Technology for more efficient and funded training
 options.

Board Member **Sonya Johansen** and **Registrar** represented the Association on the review working group. The Registrar acknowledged and thanked Sonya for her valuable contribution and commitment throughout the process.

Wool Alliance

The **Certificate in Wool Technology Review Group** sent a letter to the newly formed **Wool Alliance**, highlighting the importance of maintaining high standards in wool training and education across New Zealand. The letter, to be tabled at the November NZWCA Board meeting, encourages the Wool Alliance to lead advocacy for provider uptake and delivery of these qualifications.

The **Board reaffirmed** its commitment to continue advocating for improved wool harvesting training and education.

Classer prefix upgrades

Following the pre-lamb 2024 period, there has been a strong level of engagement from wool classers—particularly **Provisional Classers**—seeking to upgrade their prefixes through the NZWCA process. A number of test results and clip summaries have been submitted and are currently being reviewed for inclusion in the **NZWCA Register**. It was noted that some classers are still developing their understanding of the required documentation standards.

WRONZ Scholarship

A formal request has been sent to **WRONZ** seeking continuation of the **\$5,000** annual scholarship, which supports five Certificate in Wool Technology students. Verbal confirmation of support has been received from Tim Lonsdale, with written confirmation pending.

The initial notice to tutors in July did not result in any applications, likely due to communication gaps. The notice has since been resent with a revised, shorter application period.



Store classer

A visit was made to the **Christchurch wool store** to review the new store classer registration process and the store management/classing inspection framework. Questions from two potential applicants and their supervisors were addressed.

Key outcomes:

- It was agreed that lines presented for inspection could be group lots if no bin room was available.
- The existing application form, requiring the applicant and supervisor to confirm that inspected lines are wholly the applicant's work, was deemed sufficient to address concerns.
- Time was also spent advocating for NZWCA's work and explaining the rationale and support for the reintroduction of store classer registration.

MPI/PETA

The Board noted that [Name] is a member of the **MPI-facilitated People and Culture Workstream**, established in response to the PETA videos released last year. Attendance at online meetings has been maintained, with contributions made as required.

It was noted that **Tracy**, who chairs a related group, has been fully engaged with the **NZ Shearing Contractors Association** on responses and can provide further updates.

National Council of NZ Wool Interests Inc

The Board noted that Marg fully supports **NZWCA** maintaining its associate membership. Although unable to attend the recent AGM due to pre-lamb commitments, contributions were made beforehand via the Chair, including a written update on the **NZ** Certificate in Wool Technology review.

Marg also participated in a small council group tasked with **reworking the constitution** to ensure compliance with new incorporated society rules, drawing on prior experience with the NZWCA constitution. The Board acknowledged the value of this contribution from the NZWCA/associate member perspective.

North Island Industry Day

Marg expressed appreciation to Sonya for her support in planning another event in 2025. The organiser acknowledged that it was their responsibility the event did not proceed as planned this spring, citing difficulties securing suitable venues and speakers. Previous North Island Days had relied on wool samples from Massey University, which were no longer available. However, Marg has now assembled their own set of micron-tested samples (12–40 microns) and intends to attempt running the event again in 2026.

Young Farmers Club

NZWCA maintained a North Island presence this spring through participation in the Waikato/Bay of Plenty Young Farmer of the Year regional event in early November. Using the newly prepared wool samples, three wool exercises were developed for the shearing/wool module, co-hosted by the organiser (representing NZWCA) and Edsel (representing shearing and *The Lifestyle Block Bloke*). The event involved 29 contestants and provided strong NZWCA visibility, with participants gaining valuable introductory wool knowledge.



Classer Awards

Acknowledgement was given to Don for submitting nominations. Reminders are being sent to brokers to encourage further nominations and outline the simple online process. Communication with sponsors is ongoing to confirm their continued support, though a review may be needed as the **Crossbred** and **North Island** award categories have been difficult to sustain. Board members are encouraged to promote the awards within their networks, noting that **nominations can be made by brokers, buyers, and exporters**.

Board Discussion

Cassie asked about the number of award nominations received to date. Marg advised that only Don has submitted nominations so far. She noted that nominations remain open until the **end of February** and that a **reminder will be sent closer to the closing date**. Marg also confirmed that **nominations must be submitted through the NZWCA website**.

Newsletter

Work has begun on compiling content for the **end-of-year newsletter**. A key focus will be highlighting the renewed importance of **quality clip preparation**, particularly for **crossbred and stronger halfbred wools**, in light of improved market prices—timely messaging ahead of mainshear. Board members are invited to contribute articles or photos (e.g., from prelamb) within the next 10 days. It was noted that recent newsletters have largely been compiled by the Registrar, who expressed appreciation to the Board for their engagement and support.

Tracy acknowledged Marg's comments and expressed **sincere gratitude to Annette**, noting that her **efficiency**, **commitment**, **and continuity** contribute significantly to NZWCA's operations and extend well beyond her formal role as Secretary. Tracy fully endorsed these sentiments.

10. 2026 Classer Day/AGM - Update

NZWCA 2026 AGM/Industry Professional Development Day

The 2026 Industry Day has been scheduled for **Friday**, **15 May**, at the **cookshop of Peter Lyon Shearing in Alexandra**, supporting the goal of rotating the event around the South Island. Peter and Elsie Lyon have offered their venue, will provide catering, and will speak on "Things that classers do that are helpful and unhelpful," continuing the established series. **Willy McSkimming** may also contribute to the contractors' segment (to be confirmed). **Vorne Wheki**, a previous presenter on the classer–presser relationship, has agreed to re-present in 2026, with the session to be recorded for the **NZWCA YouTube channel**.

Collaboration with **Kevin Waldron** on wool samples and exercises continues, with plans to repeat the ultra and superfine classing exercise and ensure sufficient time for learning discussion. **Tracy** will chair a **panel of experienced classers** addressing "what to do when things go wrong," allowing time for open questions. There will be **no off-site visit** this year; all activities will take place at the venue. As usual, an **in-person Board meeting** will be held the evening before. **Travel expenses will be reimbursed**, and **accommodation arranged and paid for by NZWCA**. Assistance from Board members on the day is appreciated and essential to the event's success.
